## USDA Previews Emergency Relief Assistance for Agricultural Producers Who Incurred Losses Due to 2022 Natural Disaster Events

Agriculture Secretary, Tom Vilsack, announced plans to roll out \$3.7 billion in Emergency Relief Program (ERP) and Emergency Livestock Relief Program (ELRP) assistance, to crop and livestock producers who sustained losses due to a qualifying natural disaster event in calendar year 2022. USDA is sharing early information to allow producers time to gather documents in advance of program delivery. Through distribution of remaining funds, USDA is also concluding the 2021 ELRP program by sending payments in the amount of 20% of the initial ELRP payment to all existing recipients.

## Important Dates

- June 1<sup>st</sup>-June 30<sup>th</sup> – 2023 Wheat and barley revenue protection harvest price measurement based off the July board.
- July 1<sup>st</sup> – Final date to make changes or to transfer existing policy to FARM Inc. for 2024 DRP, LRP and LGM policies.
- July 15<sup>th</sup> – Acreage reporting date for 2023 spring crops (beans, chile peppers, corn, cotton, ELS cotton and grain sorghum).
- August 15<sup>th</sup> – Premium billing date for 2023 Spring and Fall crops, as well as forage production.
- September 1<sup>st</sup> – Premium billing date for 2023 PRF policies.
- October 31<sup>st</sup> – Final date to make changes or add coverage to your 2024 fall crops and cancel forage production policies.
- November 20<sup>th</sup> – Final date to sign up or make changes to 2024 citrus policies.
- December 1<sup>st</sup> – Final date to sign up or make changes to 2024 PRF policies and acreage reporting deadline for PRF policies.
